



LETTER OF INTENT BETWEEN

THE

BOARD OF REGENTS OF THE UNIVERSITY OF NEBRASKA on behalf of the UNIVERSITY OF NEBRASKA-LINCOLN AND

THE NATIONAL AUTONOMOUS UNIVERSITY OF HONDURAS

On the one hand, HARVEY PERLMAN acting in his capacity as Chancellor of the University of Nebraska-Lincoln (hereinafter "UNL"), the institution which bases its headquarters in the city of Lincoln, Nebraska, USA;

On the other hand, Dr. JULIETA CASTELLANOS RUIZ, acting in her capacity as Chancellor and legal representative of the National Autonomous University of HONDURAS (hereinafter "UNAH"), as stated in the Appointment Agreement No. 13-2013 - JDU -UNAH of the Board of Higher Education Management; institution based in the city of Tegucigalpa, M. of the D.C., Honduras. Who according to their respective positions and the exercise of the powers conferred on them declare the following:

- 1. **PURPOSE**. The purpose of this document is to manifest the willingness of both institutions to cooperate in the areas of academia, research, links with society and other issues of mutual interest.
- 2. **ACTIVITIES**. For this purpose, the parties will be able to promote the development of the following activities:
 - a. Design and/or development of academic programs at the technical, undergraduate or graduate levels.
 - b. Teaching and/or administrative staff visits to work, negotiate, exchange of experiences and other issues.
 - c . Design and/or joint development of research plans, teaching and training in areas of common interest to both institutions.
 - d . Exchange of publications and academic materials, as long as not limited by law or by contractual obligations.
 - e. Symposia, conferences, courses, seminars and cultural activities in both institutions.
 - f. Exchange of faculty, technical staff, and students.
 - g. Joint development of projects relevant to society.
 - h. Collection and management of funds towards financing programs and initiatives of common interest.
 - i. Any further collaboration of mutual interest.
- 3. **IMPLEMENTATION OF ACTIVITIES**. The definition and implementation of the described activities in this letter may be agreed by the parties through the creation or development of specific Memorandum of Understanding's and will depend on the availability of the necessary resources.

4. **EFFECT.** This letter will be effective one (1) year from the date of the last signature or until an agreement that replaces it is signed. It may be renewed for the time stipulated by the parties, if both express in writing their interest to do so to least one (1) month before the end of the current term. Either party may terminate this letter of intent, by a fifteen (15) days notice in writing to the other party.
